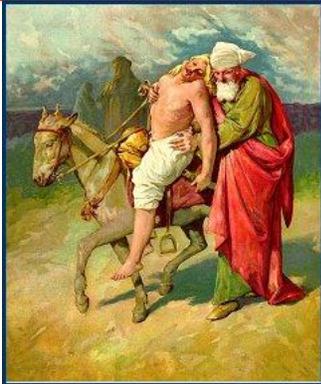

## WHAT IS A CHRISTIAN'S RESPONSIBILITY TOWARDS AUTHORITY AND GOVERNMENT?

When growing up, it was common for us to be sitting at the kitchen table eating our dinner while watching the 6:30 PM news on our small kitchen television. My father would make a point of keeping abreast of the daily news. We knew to speak only during commercials, and that was only if my father had no comment about what he just heard. He was always interested in hearing opinions, even when it came from a child's limited fund of knowledge.

Having immigrated to this country in 1950, my father and mother were very appreciative and respectful of the democratic freedoms in the U.S.. My father may not have agreed with government opinions or decisions, but he always taught us the importance of obeying the laws of government. He often said, *"Always give back to the government what you owe in taxes and allegiance."* (Romans 13:7) He even changed from an Independent to a party affiliation, so he could have more voting opportunities.

With all the turmoil occurring in the world today, I often remember my father's words of obeying and respecting the government and the offices of leadership, even if you do not agree with them. The same is true with local, company, family, and church governing laws and leadership (Romans 13:1).

In a Christian/Hebraic society, we are supposed to be appointing officials by God's standards. In like manner, those officials we appoint (vote) into office are to use righteous judgment - hearing and obeying the Spirit of God - without taking payoffs in money or special favors. God's standards apply to both the voter and the elected officials, for to accept bribes or special treatment *"...blinds the eyes of the wise and perverts the words of the righteous."* (Exodus 16:18-19 AMP)

Whether the appointer/voter or appointee/elected official, the Bible tells us that we are to make our decisions based upon our close relationship with God - right standing with God (Psalm 9:4).

*"...but let him who boasts boast of this, that he understands and knows Me, that I am the LORD who exercises lovingkindness, justice and righteousness on earth; for I delight in these things," declares the LORD.*" (Jeremiah 9:24 NASB)

When people who obey God elect leaders that follow God's standards, only the rebellious should have reason to fear the authority given to the unscrupulous. To rebel or make selfish decisions is to go against God's appointed and divine order - consequences are inevitable (Romans 13:2-3).

*"By me Kings reign and rulers decree justice. . .He changes the times and the seasons; He removes kings and sets up kings. He gives wisdom to the wise and knowledge to those who have understanding!"* (Proverbs 8:15; Daniel 2:21)

Making wise decisions becomes exponentially more difficult after each self-centered decision. Understandably, when we do not follow God's standard, we then justify our self-centered decision by lying to ourselves and others. In doing so, we are, bit by bit, numbing our conscience, making it more difficult to hear from the Spirit of God (Romans 13:5).

*"God's Spirit spoke through me, his words took shape on my tongue. The God of Israel spoke to me, Israel's Rock-Mountain said, "Whoever governs fairly and well, who rules in the Fear-of-God, Is like first light at daybreak without a cloud in the sky, Like green grass carpeting earth, glistening under fresh rain."* (2 Samuel 23:3 MSG)

Would it not be wonderful if, whether in the secular or religious realms, we base our every decision on the love of God and love of one another (Romans 13:10)? This is not a fantasy, but a truth based upon being Christ-centered rather than self-centered.

Instead of being torn by secular and religious conflicts of this day, put on the Armor of God, *"...But clothe yourself with the Lord Jesus Christ (the Messiah).*" (Romans 13:14 AMP).
